[A church in America can organize so as to glorify both God and man without persecution because of the highest law of the land concerning church state relationship: the First Amendment to the United States Constitution. That alone cancels the false Romans 13 argument given by many churches for betraying God through incorporation, 501(c)(3), 508(c)(1)(A) or other "legal" status which places a church under man's laws.

Activities of the Month for June 2020

Helping a new church plant organize as a "Church under Christ" totally outside the authority of civil government. This church will be made up of members leaving an established church. The members who are planting the new church tried unsuccessfully for a year or more to persuade the church leaders to reject the government's authority

over the church. The new church plant has carefully followed the ministry procedures. They will execute documents establishing a "Bible" trust as soon as everyone has moved to their new location. This ministry helps churches, not stand alone ministries outside the authority of a local church under Christ, organize according to the principles in the New Testament. That said, I will give you a nutshell answer to your									
question.									
You do not want to organize "legally" (i.e., as an incorporation or 501(c)(3) or 508(c)(1)(A) tax exempt									
organization under man's law.									
But then again, you want to organize legally some other way. There are various other ways to organize legally:									
as a business (sole proprietorship, LLC, etc.), as a charitable trust, as a business trust, as an unincorporated									
association, etc.									
However, the only way for a "ministry" to get tax exempt status is to apply for 501(c)(3) status. Churches are									
automatically exempt and may also claim 508(c)(1)(A) status, but that puts them in the same position as 501(c)(3)									
status. See, Church Internal Revenue Code § 508(c)(1)(A) Tax Exempt Status.

You may wish to consult a CPA to verify what I say. Anyone can give gifts to anyone, as long as the IRS we classify them as "gifts." The IRS Code allows up to a certain amount of gift to a person (and I assume to 'ministry") each year without any tax consequences. However, the giver may not deduct the gift on their incommax return unless the "ministry" or organization is tax exempt under 501(c)(3). In Christ lerald Finney

I explained the basics of how to open a trust bank account, getting an EIN for banking purposes only, the SS-4 and Inistructions, etc. Told him that when the time comes I will go over it all with him, that he will need to send me the completed SS-4 Form before submitting it so I can double check that it is filled out correctly, etc.
