1. A BRIEF REVIEW OF SOME DEVELOPMENTS AND ACTIVITIES DURING JULY 2020

(For a more complete report on ministry activities, see the Activity Log on pages 5-17.)

Jul 1 Inquiry about setting up a Declaration of Trust for a church to open in 2028. I sent links to web pages which lay out CUCM policies, procedures, and guidelines

July 2: Request for assistance in getting out of church corporate 501c3 status. Pastor said he had never felt right about it, but another pastor advised him when planting the church. After spending a lot of time on the phone with him and sending him the initial letter, the policies, procedures, and guidelines, and Questionnaire 1, and receiving back Questionnaire 1, I had to inform him, on July 11, that the ministry cannot help because the church approves of women pastors, as revealed on the completed Questionnaire 1.

July 2: 070210 I received a call recently from Bro. ______. He said he had not gotten his EIN. I advised him to call to see what the problem was. He called me back and said they had no record of his application. He resubmitted the SS-4. He called me on 070220. He got the EIN. His next step is to open a trust bank account. I advised him on how to approach that.

July 3: In response to an email inquiry from a "ministry" or some type of organization, I informed the sender that this ministry only helps churches who desire to organize according to the principles of the New Testament.

Jul 3: Sent intitial mailing--The initial letter; Policies, Procedures, and Guidelines; and Questionnaire 1—to a pastor who first contacted me in June.

July 6: Email for a lady who said she and her husband want to take over a church which is being separated from an incorporated 501(c)(3) ministry. They want to organized the church the Bible way. I sent her an email explaining the problem with keeping an association with the ministry, etc. Turns out, she is the pastor and her husband the "praise leader." I explained that this ministry cannot help a church with a woman pastor in that the Bible makes clear that women pastors are out of order.

July 6, 2020 Replied to an inquiry from another church I had been talking with since June. Found out the church has a woman pastor. Ditto as to above.

Jul 7: Request from help from a lady who has a ministry of helps to ladies in need. My reply: "This ministry only helps churches who wish to honor Christ by remaining under His alone, or who wish to reorganize under Christ alone - completely separate from civil government through incorporation, 501c3 or 508c1A, or any other type of status which places them under an authority other than the Lord Jesus Christ. The ministry does not help other types of organizations."

Jul 7: Inquiry from a "one woman ministry" of helps to folks one on one to assist them with inner healing, deliverance, and general discipleship. My reply: "This ministry only helps *churches* who wish to honor Christ by remaining under His alone, or who wish to reorganize under Christ alone - completely separate from civil government through incorporation, 501c3 or 508c1A, or any other type of status which places them under an authority other than the Lord Jesus Christ. The ministry does not help other types of organizations."

Jul 7: Inquiry from a man (on behalf of his pastor) who wishes to call you concerning a new unincorporated church plant. He said that there is an affiliated school. Church does not exist yet. Owns no property. They have an auditorium they can use from the other ministry. Etc. We talked to him for an hour orl initially directed him to so. Put him on email list and emailed link to CUCM page. I initially directed him to the following web page for procedures (links 6-11) used by this ministry: Churches under Christ: Church organization according to Bible doctrine and the First Amendment and agreed to send the initial mailing within a week. Prepared and sent initial mailing on July 15. Received back an email stating that he received the initial mailing and will get back with me after the pastor and his wife get over their illness. On July 22, I received completed Questionnaire 1. Since receiving competed Questionnaire 1, my computer crashed which cost me a couple of days, and the pastor and I have been playing phone and email tag in an attempt to set up a conference call.

July 15, 2020 Prepared and sent initial mailing and Questionnaire 2 to ______ [have been working with this church for some time, and am satisfied the church will meet the qualifications on inquired about on Questionnaire 1. Nonetheless, asked that Questionnaire 1 be completed.] Received an email that: "It will be a few weeks before we respond. Our meeting to possibly vote will be July 26. On July 15, [thepastor] wrote: "Hello Jerald. I was reading over your questions and I am curious as to what in particular you base your KJV statements:

The principles in the King James Bible are those we rely on and must proceed with. You may wish to use an interpretation for your teachings, sermons, etc., but we cannot help you if you do not agree that the KJB will be the basis for the separation of your church from the state in all matters.

are there principles here that you apply to that are not found in NKJV? Or any of the critical texts? I happen to believe that the Textus Receptus is the reliable source text for the english bible, but I am curious as to what in particular you mean by KJB principles. Are these not evident in the modern bibles? Thank you Jerald!

July 21, 2020 Updated the article Obtaining a Church Common Law Trust Employee Identification Number "For Banking Purposes Only" (031720).

Jul 23: My computer had crashed and it took a couple of days to get it fixed. I replied to an inquiry by explaining this and: To get things started, you can look at the ministry procedures (pages 6-11 linked to on the following webpage) for helping churches at: Churches under Christ: Church organization according to Bible doctrine and the First Amendment. Also, feel free to give me a call. If you get a voice mail, just leave a message and I will call you back asap. Call from the pastor on July 24. He listens to Mark Taylor. He has a moe group. The corp. 501c3 status belongs to the overseeing church. The overseer ordained him, but when he talked to the overseer, it was him

ministering to the overseer. The overseer is non-denominational. He oversees his own ministry. That ministry has not flourished. That ministry is incorporated. Bro. _______ is under his 501(c)(3). The overseer did all the paperwork. The ministry has been small. {They do some good work, according to the pastor.] Etc. He will talk to his overseer about terminating his corp. 501c3 status. I sent him an email (below). Put him on email list. I explained in a nutshell, the trust concept. He wants to work toward that. I sent him links to webpages for him to study out, but, to make a long story short, after learning the details of what he is doing, I had to inform him that this ministry cannot be of help.

July 23: Message received: I'm new to the 501 c 3 and I want The Lord and Savior Jesus Christ to be the head of my ministry he put me to be over. Thank you and Mark Taylor for speaking the truth and spiritually educating us. I replied that he could give me a call to discuss whether this ministry can help. Also, "Perhaps you may wish to look at the ministry procedures (pages 6-11) for helping churches. See the following webpage: Churches under Christ: Church organization according to Bible doctrine and the First Amendment. Etc. He replied "Thank you so much for responding to me. I'm going to get some ink for my printer and print all the information for my church and have it on hand for to educate others. I will call you soon."

July 24: Returned call to [a lady] who called about getting church out from under 501c. She was alerted to 501c3 by Mark Taylor and wants to bring it up to her pastor. I talked with her for some time. First, I must inform you that this Churches under Christ Ministry is in Bible order. It is under the authority of Charity Bantist Tahernacle of Amerillo, Tayas, The King James Bible (the "Bible") is the authority for all matters of

Charity Baptist Tabernacle of Amarillo, Texas. The King James Bible (the "Bible") is the authority for all matters of faith and practice for this ministry and Jerald Finney, the head of the ministry.

This ministry helps *churches* who wish to organize under the principles of the New Testament. According to the Bible, God ordained local churches or assemblies under Him to do His work.

That said, a ministry can simply choose not to "register, unless it happens to be classified as a business or unless it makes profit. Of course, each person involved in the "ministry" will need to pay their taxes, if any is due. A "ministry" can, if incorporated, dissolve the corporation. That will end the 501(c)(3) status of the "ministry." If there is no "ministry" anymore, how can it have 501(c)(3) status? It cannot. Of course, one must consider the fate of any assents according to civil law.

A new ministry can be started without "registering." If the old ministry is no longer in existence, what is to stop a person or persons from starting a new "ministry?" Nothing.

Depending upon the nature of the organization, it may be classified as a business, even if not organized as a corporation or some other entity. Businesses are far different than "religious or charitable organizations." If the organization makes a profit, it will need to pay taxes. It may not receive some benefits which churches receive such as sales tax or property tax exemptions. See a lawyer and/or CPA in your state about those matters.

Also, Peter Kershaw offered some good information, but his techniques were very flawed. I have his books, including *Hushmoney*. He was also a very good con-artist.

I was referred to you by a representative at the Homeschool Legal Defense Association whom I had contacted about our homeschool group's rights with regard to meeting together for instruction this school year and whether or not we fall into a category exempted from the state mandates.

I have read Governor Abbott's mandates repeatedly, as well as statements from AG Ken Paxton*, but before I can determine what rights we have as a group and where we fall within the mandates, I need to determine into which category our particular organization belongs. That's where I'm unclear.

We are a religious homeschool cooperative, made up of 13 families, operating in Fort Worth, Tarrant County. I know in Texas our individual homeschools are considered private schools and ours happen to be religious in nature, as is our collective group. However, we are not a legal entity, non-profit or otherwise. We have a nice official-looking handbook that states our beliefs and objectives, but no legal representation or status.

The AG says religious private schools and "religious communities" are exempt from the state mandate prohibiting groups larger than 10 from meeting in public. But what does that mean for a small group of families with no legal status? And what if our only meeting location option is a shared public space, like a park, rather than our own facility? Does our group have any of the same "rights" a church or private school has?

Is this an issue you can help me with?

Thank you for contacting me about your situation there in Tarrant County. I can only briefly offer you some thoughts off the top of my head.

Individuals have legal status. So the parents of the children, and the children, have legal status. Just as a bowling league has no legal status, but the members of the league do.

From what you say, the AG exempts private schools and "religious communities." Does he also say that the private schools have to have legal status; that the "religious communities" have to have legal status, to be exempt?

You stated that home schools are considered "private schools." So your school is a private school.

Two definitions of "community" are:

- 1. a group of people living in the same place or having a particular characteristic in common. "the scientific
- 2. a feeling of fellowship with others, as a result of sharing common attitudes, interests, and goals. "the sense of community that organized religion can provide."

I believe your private religious school could be defined as: "a school supported by a private organization or private individuals rather than by the government."

There is obviously no state requirement that private schools and religious communities be legal entities such as corporations, 501c3 or 508c1A organizations exempt from federal taxes. I know of no home schools which are organized under government law (as are non-profit corporations, 501c3 or 508c1A tax exempt organizations), have

"employees," pay "salaries," etc., as do public schools. If they did so, they could be declared to be legal entities just like a non-incorporated business or a public school.

Without research, I do believe your private school is exempted.

No, a private school is not like a church in that it is not protected by the religion clause of the First Amendment. However, parents are protected by the "free exercise clause." The religion clause is made of of two clauses, the establishment clause and the free exercise clause. I would imagine that perhaps the free exercise clause may be a defense of the right of parents to home school their children. I do not think that the meeting location(s) would be relevant to the issue.

You can ask the AG for an opinion on the matter.

I now give all me time to the "Churches under Christ" ministry which helps churches who want to honor the First Amendment and the New Testament teaching on the local church remain solely under the authority of the Lord Jesus Christ (to remain non-legal entities outside the authority of civil government). I simply do not have time to take on your issue. I hope what I have said may give you some insights into your dilemma.
