1. A BRIEF REVIEW OF SOME DEVELOPMENTS AND ACTIVITIES DURING AUGUST 2020

(For a more complete report on ministry activities, see the Activity Log at the end, starting on page 6. Of course, the most trivial matters are not included here or in the log at the end.)

Sep. 1: Mailed Questionnaire 2 to Pastor . Published September 1, 2020 Churches under Christ Newsletter.

Sep 3:

- Inquiry from lady concerning whether it would be better to "file a 501c3 versus a Charitable Trust" for a new organization to care for drug-exposed infants and young children. I called her about this and talked to her at length. I gave her some advice but explained that this ministry only helps churches who wish to be under the authority of the Lord Jesus Christ and him alone. I learned that she wishes to totally combine the holy with the unholy. As an attorney, I came into contact with many such "faith-based" ministries and those they purport to help. Those ministries were devoid of Biblical knowledge, understanding, and wisdom; therefore, contributing to the downward slide of individuals, families, and the nation. Just being honest.
- Call from a gentleman about, as he put it, "A New Testament Church of God." He was a relatively new Christian. He was an elder of a church. He got into the by-laws and was appalled at what he found. He heard Mark Taylor. He would like to set up a New Testament Church. He concurs completely with all he has seen on the website. He wants a New Testament apostolic church set up. He is not called to be a pastor. But the group he is involved with has several ordained pastors. He is spearheading the effort. Some of them are on the same page. They want to move the families onto a couple of thousand acres. Etc. We talked about a lot of things, and I advised him and gave him thoughts. He agreed that a church under Christ cannot have or approve of women pastors, deacons, officers of any kind, or women with any authority over men. Added him to email list.
- Sent initial mailing to a pastor. He returned, via email, completed Questionnaire 1 the same day. He also had some questions. After reviewing Questionnaire 1,I had to reply that we could not help him.
- Replied to an email from a faithful follower of this ministry.

Sep. 4: Email from a young man about setting up a church the right way and "setting up a trust account." Contacted him and told him I was very busy and would call him as soon as I had time. Contacted him on Sep. 9 and talked with him for quite a while. He had been referred by a California attorney whom he contacted about the matter. That attorney told him to contact me as I was recognized as an expert in this matter. On September 14, I mailed him a copy of *God Betrayed*.

Sep. 9:

- Email from a pastor concerning "Subject: unregistering an independent baptist church." Replied to his email stating that I would be glad to discuss this with him. He called me on Sep. 10 and we talked for some time.
- VM from a gentleman who moved from New York to Texas and wants more info on setting up or process of setting up a charitable remainder trust. Already working on 1023 EZ form. Said he believes in what he has read of my materials about building a church. Said he sent me an email yesterday. I returned his call. He is looking at starting a church and how to organize it. He is an ordained minister. His goal for church organization is that his wife is going to do a youth and children's ministry. I talked with him for quite a while, going to numerous Scriptures, etc. We discussed God's ordained institution for doing His work in this age of Grace, the heresies and apostasies of most churches. I went to numerous Scriptures. Emailed him links to the KJB page, Dr. McGee's online teachings, and the sermon, Ten Shekels and a Shirt.
- Sent email was in response to gentleman who called asking for Greg Jr's email address in order to inquire about getting a copy of Dr. Dixon's book. He also said the church he attended right out of the box says obey every government law. The pastor said that he had not been bothered by civil government officials who were not telling the church what to do .or preach. I replied with the address and sent him a link to the Churches under Christ website.

Sep. 10: Call from a pastor who got my info. from Chuck Baldwin. Wants to reorganize – get out from under 501c3. He has been encouraging churches to get out of 501c3. He has been encouraging his pastor. The pastor is in favor of doing it. Other pastors are not. His church currently owns considerable property. He has been trying to get his pastor to do this. They also operate a school. They have over \$100,000 in fines for opening during the "pandemic." They have continued to open regardless. The church is 40-50 years old. They have a church school with tuition, fees, etc. We talked for a couple of hours or so. Discussed a lot of matters concerning how the church can come out from under state control (can become a church under Christ alone). Great call.

Sep. 11: Email from a church member of a church with which I have been working for some time. He is working with his pastor in the process of getting the church, which now owns considerable property, out of the corporate 501(c)(3) status. The church had to come up with a new name in that it is not wise to keep the same name in this situation. He stated: "We finally came up with a name. It is _____. ... I have attached the completed questionnaires. Please let [pastor] and I know how to proceed." On Sep. 12, I replied that I would get with him early next week. I did so, and prepared and emailed him sample documents for establishing a common law trust.

Sep. 12: Called a lady in reply to her text in which she said she was starting a ministry (______, a home group). She wants to stay out of 501(c)(3) status, but also some of the folks want an IRS acknowledgement for gifts and offerings. Explained to her that you cannot have both. Explained 501c3 and 508c1A, etc. Emailed her links to some studies of 501c3 and 508c1A. Of course, this ministry cannot help her if it is a "mininstry" and not a church or, if it is to be a church, it does not meet basic New Testament requirements such as "no women pastor or officers of any kind." She was a very courteous lady and seemed to love the Lord.

Sep. 13: I received an email asking: "Are there any "churches" in California that are not part of this 501c3? Continuing email exchanges continued for several days.

Sep. 14:

- Call from a trustee who had submitted the SS-4 for EIN "for banking purposes only." He sent me copy of the completed SS-4 to me and it was correctly filled out. I told him to call 800-829-4933, the number on page 2 of the Instructions for Form SS-4 to check the status of the application. If they have lost it, he plans to send another application via fax. Sent him the above phone no. and link to instructions for Form SS-4.
- Email from a lady in Lubbock, Texas looking for a non-501(c)(3) church in Lubbock. I replied: "Regretfully, I know of no non-incorporated, non-501(c)(3) church in Lubbock. Asked her if she were and her husband were saved, to which she replied that they are.

Sep. 22:

- Call from a gentleman whose dad is starting a "ministry." His dad was a pastor for 30+ years, semi-retired, but wants to get back into a ministry. His dad does a facebook video, writes books, & does conferences. He has started a board of directors. He wants to provide tax exempt status but does not want 501c3. I explained 501c3 and 508c1A status, the First Amendment, etc. I explained that this ministry helps churches who do not want to be under the authority of civil government. Explained my beliefs about stand-alone ministries as opposed to churches, etc. Also discussed the motivation for giving, the only institution ordained by God to do his work, the local church, that all of God's ministries should be under the authority of a local Bible believing, Bible practicing New Testament Church under Christ and Christ alone, etc. He asked about resources which go into these matters. I told him about ministry books that are all available online for free, including PDF versions and some of which can be ordered from Xulon Press, Amazon, and Barnes and Noble. Sent him links to online essays on 501c3 and 508c1A.
- Conference call with church member and Pastor in a Colorado church. We went over completed Questionnaire 1 & there were no issues. I answered their questions. Next step is Questionnaire 2. Answered their questions about opening a a bank account. Explained that I have a PowerPoint that I will email them, when the time comes after the trust is established, that explain how to get a banking number for the bank account. The pastor of the church in whose facility they had been meeting has not allowed them as well as the home church to meet there for 6 months, so they have not paid the rent and have not paid for the insurance. They have a about 60 members including children, so they have alternated meeting in homes of some members which are large enough to accommodate their assembly. Discussed some other matters with them as well. Emailed Questionnaire 2.

Sep. 23: Drafted and emailed sample trust documents to a church with whom I have been working for some time.

Sep 25: Received the following email inquiry: "Do you have an article outlining a good way to approach a conversation with my Pastor in reference to looking into getting out of the 501c3?" I replied: "Of course, there is no standard way for one to approach a pastor about this matter. The main thing, I believe, is to approach the pastor with an understanding of the Bible principles; the facts about incorporation and 501c3; and the ways incorporation and 501c3 violate Bible principles. Most pastors will not entertain a sincere debate about these matters. If they even discuss the matter, usually they give excuses which do not hold up to scrutiny. Sep. 10: Call from in Indiana, Indiana. Starting pasturing the church there in January. Trying to figure
out how difficult it would be to get out of 501c3 corporation. Church has been there 43 years. He is concerned
because of churches being fined for holding services. He mentioned Northview Baptist Church in Calif. that has 50-

Returned call. Left VM. Sep. 10: We connected. He is looking at starting a church and how to organize it. He is an ordained minister. His goal for church organization is that his wife is going to do a youth and children's ministry. Michelle, will run the women's groups. All donations go to setting up this charity trust. To set up a charitable trust, he found a company called Fidelity that sets up charitable trust. Charges \$5,000. Have to first get 501c3 status.

There is a small group of them who belong to a church where everything was about building wealth, etc. It was all about the world. Moved to TX from NY. The old church said that 90% is yours, but you give 10% to the Lord. It's a business, a show. He saw it in NY. Got in a youth group, going around talking about the word of God. The focus there was on the Word. Went into what is the Bible, the business churches he has been associated with. What he is seeing does not make sense.
